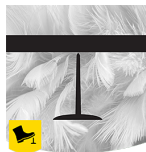

Ultralight high-tech material, metalfree with no thermal or electrical conductivity.



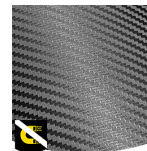
### SRC slip resistance
